1. I, hereby irrevocably grant to InFaith, its subsidiaries, affiliates, nominees, licensees, their successors and assigns, and those acting with its authority (hereinafter collectively referred to as "the Mission"), with respect to the photographs, film, or tape taken of me by or on behalf of the Mission ("Pictures"), the unrestricted absolute, perpetual, worldwide right to:

(a) Reproduce, copy, modify, create derivatives in whole or in part, or otherwise use the Pictures or any part thereof in combination with or as a composite of other matter, including, but not limited to, text, data, images, photographs, illustrations, animation and graphics, video or audio segments of any nature, in any media or embodiment, now known or hereafter to become known, including, but not limited to, all formats of computer readable electronic magnetic, digital laser or optical-based media ("Works"), provided, however, that the rights granted to you herein shall not permit exercise of these rights as a direct commercial endorsement by me of any product or service (other than the Pictures), without first obtaining my consent, and

(b) Use and permit to be used my name, whether in original or modified form, in connection with the Works, as the Mission may choose, and

(c) Display, perform, exhibit, distribute, transmit or broadcast the Works by any means now known or hereafter to become known.

2. I understand that although the video editing process will likely require some of my speech to be deleted or rearranged to fit the scope of the finished documentary, and although the Pictures themselves will endorse a Christian worldview, the Mission will not intentionally manipulate my words or image in such a way that makes me appear to directly endorse views or beliefs I do not hold.

3. I hereby waive all rights and hereby release and discharge the Mission and its employees, agents and servants as well as all parent and subsidiary companies and their affiliates from any and all claims and lawsuits based upon or related to the use and exploitation of any pictures, photographs, video and the waiver specifically relates waiver of all known and unknown claims, demands, causes of action, lawsuits based upon the Mission's negligence, gross negligence, recklessness, breach of contract, defamation, libel, slander, invasion of privacy, and all other personal injury claims arising out of, or related in any way to, the use and exploitation of any pictures, photographs and videos.

4. I agree that there shall be no obligation to utilize the authorization granted by me hereunder. (InFaith may choose not to use the footage in which you appear.)

5. All parties agree that should there be any dispute arising out of this contract and the use and exploitation of pictures, photographs, and videos, suit shall be filed only in the Delaware County Court of Common Pleas located in Media, Pennsylvania.

The terms of this authorization shall commence on the date hereof and be without limitation.
